Due to the recent Paris attacks, where it was discovered that at least one of the terrorists came into the country posing as a Syrian refugee, the United States has been weary of incoming refugees. Yet, turning away refugees and making immigration more complicated is not the answer.

A bill passed by the House of Representatives on Nov. 19 suspends the program that was designed to allow Syrians into America until security agencies can be clear that they do not pose a risk.

This puts into question what U.S. political parties stand for. Many Republicans seem to follow the Bible, yet they are restricting these poor, weak and broken refugees from coming into the country who need a safe place to stay. That is going against the very beliefs that they claim to follow.

On the opposite side, Democrats are supposed to be the party that stands up for the lower classes and has been standing up for immigration in the past. Both parties being controlled by fear so much as to make a rash decision to slow the process of allowing in the widows and orphans from Syria.

In Texas, Greg Abbott has stated his opinion on the subject by claiming that Syrians are too much of a security risk and that they should not be allowed into the Unites States at all. Abbott is so against letting Syrians in, that he wrote a letter to President Obama voicing his opinion about how Syrians will expose U.S. citizens to danger. A part of the issue that no one seems to notice so far is how this has happened before. History has already begun to repeat itself through the refugee issue.

Back before World War II began, a boat named the St. Louis sailed from Germany to Cuba in hope of seeking refuge from the Germans. The boat carried more than 900 passengers and when Cuba only allowed 28 passengers in, they denied the rest entry. The passengers on the St. Louis turned to the United States for shelter but were turned away again and forced to return to Europe. Half of the passengers were able to find refuge in other European countries. Of the 532 passengers forced back to Germany, only 278 survived the Holocaust.

This mistake could have been avoided if the United States had let in the refugees. The leaders of this country are deciding that they know best even though the result has already been played out in the past. Turning away Syrians means that our own leaders have learned nothing. If Syrians are not allowed in, then we are making the same mistakes.

A big reason for this fear of Syrian terrorists started a while back when 9/11 was first attacked. The fear was built upon over the years and reached a high point when ISIS stepped in. ISIS began terrorizing the middle east and threatened the west with the murders of American journalist in late 2014. When the Paris attacks took place, this fear was ignited According to CNN, at least one of the terrorist in the attacks came to France, posing as a refugee. While this is terrifying, it should not lead to the refusal of these refugees.


